PRESS RELEASE

We can confirm that the Police and Crime Commissioner for Leicestershire has lodged a Judicial Review with the High Court of Justice, against Blaby District Council.

The reason for doing so is that Blaby District Council has recently granted permission for 4250 new homes at Lubbethorpe in Leicestershire and the development will significantly increase the demand on policing in that area. In order to maintain the level of policing presently offered to residents in the District, Leicestershire Police require a financial contribution from the developers of the Lubbethorpe urban extension towards police equipment and buildings.

Both the Council and developer agree that a financial contribution should be made towards policing in Leicestershire, but have entered into an agreement that means no funding will be put in place for very many years, until thousands of new homes have been built. Furthermore, there is no firm commitment in the Agreement to contribute anything towards the buildings that will need to be expanded to house the additional officers and staff required to police the development.

As a consequence, acute pressure will be placed on the Force's ability to police the development effectively which is likely to impact on policing elsewhere in the area reducing

the level of service provided to existing residents.

The police are not opposed to the building of new homes in principle, but if the funding isn't put in place during the early stages of development, the impact on the service offered by Police across the county will be unacceptable.

The current situation is therefore untenable, not least because it is unfair on the local communities who depend on the police service and will see a reduction in the level of service if new development isn't prepared to properly contribute towards the extra demand it places on police resources. Accordingly, there was no option but to seek Judicial Review of the Council's decision to grant planning permission. It is not a decision that was taken lightly, and of course, it is hoped that this situation can be satisfactorily resolved without further recourse to the Courts. It is also of note that there are several, similar sized developments planned for the Leicestershire Force area and the precedent set by not taking such legal action would allow future development to exacerbate this already unacceptable situation.

Due to the active legal proceedings, it would be inappropriate for the Police and Crime Commissioner or Leicestershire Police to comment further at this stage.

I own an apartment in Leicester town centre which had previously been let out to tenants but has been vacant since November 2013

Police broke the front door of my empty property causing extensive damage to my apartment on 05/04/2014, apparently looking for a vulnerable girl

The whole issue raises a lot of questions which I would like clarification from the police who have been very callous in their attitude

The issues surrounding disappearance of a vulnerable young [REDACTED]

[REDACTED] are socio-economic and political

But it seems it is being tackled by local government in Leicester by harassing honest, tax paying, hard working citizens like me by vandalizing their property to begin with
Who knows where it would lead to?

Could you please take action on my complaint to Leicestershire Constabulary and Independent Police Complaints Commission

Besides as a tax paying citizen I would like to know what steps have been taken by the local government to help young immigrants to assimilate in society in Leicester

If newspaper reports are to be believed why this vulnerable girl didn't speak English, despite living in UK for last 5 months

That is enough time for a [REDACTED] old girl to learn a new language and assimilate into a new society

I can say that from my personal experience as I can speak 5 and write 3 languages It took me less than 2 month to assimilate into society in UK although I was much older

Enclosing a copy of my complaint letter and photographs of my vandalized property where repair to the damage would cost me between £1000-£1500 along loss of my precious personal time which is mainly devoted to care of my frail elderly parents

Dear Mr Soulsby

I have lived in Leicester for over 40 years and I was proud of the city until today.

I went into Leicester shopping with my mother and my son (age 17) cycled into Leicester at 12 noon to meet us for lunch. He has a specialised bike. He locked it up in the bike rack outside HVM and when he returned at 2pm it had been stolen. I was not with him, as I continued to shop and he was going home to carry on with his homework. The bike was his pride and joy and he is so upset. He just had enough money to get him home to [REDACTED] on the bus. He was distraught when I arrived home with my mother.

He did report it to a lady police officer in the centre and she said she would get them to check the cameras. She said there is a gang of Romanians who are known to steel bikes. What is Leicester coming to. These people should not be allowed to be in our country or city if they are stealing.

I would welcome your thoughts on this.

I am writing with regard to the email you sent to The Mayor Sir Peter Soulsby on 16 January 2014 on the subject of cycle theft.

I am also sorry to hear what happened with your sons bicycle. As this relates to an operational policing matter the issue falls under the remit of the Chief Constable rather than myself. However, it is my job to hold the Chief to account for the actions he takes regarding operational policing. My team have consulted with the Force and obtained the following information from Sergeant [REDACTED]

There are around 500 bicycles stolen each year in Leicester City Centre. The Force is aware of the distress and inconvenience it causes to victims particularly as they are often young people with no other means of transport.

The force is committed to reducing these thefts and has done a mixture of enforcement and crime prevention work. For example, at the end of 2013 they purchased technical equipment as part of an operation to target offenders. Officers were tasked to work on this over a number of weeks which resulted in 10 arrests in the city centre. The force have also painted up old bikes in bright colours with crime prevention Tri Signs attached which have acted as a deterrent and a reminder to secure bikes properly. Officers have reminded people to secure their bikes with a good quality D-locks through press releases and social media posts. The Force has purchased a large stock of D-locks which can be bought at cost price of just £5 from Mansfield House Police Station or the City Centre library on Bishop St.

This work has already resulted in a significant reduction of offences in December 2013 and the Force is confident this can continue.

There is no evidence that gangs of Romanians are stealing bikes. None of the 10 recently arrested are foreign nationals. If your son replaces his bike, then PC Cooper has offered to provide him with a free D-lock. Please contact PC Cooper on 0116 2486684 or email at Andrew.cooper1461@leicestershire.pnn.police.uk

Following recent media interest in the Lubbethorpe development a number of questions have been received. We have attempted to capture these and respond below.

Context: As has been previously confirmed, the Police and Crime Commissioner for Leicestershire has lodged a Judicial Review with the High Court of Justice, against Blaby District Council, with regard to the proposed development of 4250 homes at Lubbethorpe. This decision follows extensive discussions with senior officers within the Chief Constable's team and legal advice received. The Chief Constable is fully supportive of, and indeed has advised, this action.

Question: *Is Leicestershire Police and/or the PCC simply opposed to the planned development?*

Answer: We are not against the Lubbethorpe development – indeed, we support it with the necessary contribution to Policing. We want to see it taken ahead safely and in a timely fashion.

Question: *Why have you not raised your concerns with Blaby District Council prior to this?*

Answer: We have. We reached agreement with Blaby District Council and confirmed in December that £1.67m was required for policing infrastructures and facilities for this new development. We started discussions with them back in 2009.

Question: *So what is the problem?*

Answer: Leicestershire Police has made very careful calculations regarding the extra funding required to cover this new development. The Council and developer agree the necessity of a Policing contribution.

The problem is that the timelines or triggers that these parties have included in the s106 agreement, without reference to Leicestershire Police or the Police and Crime Commissioner, mean that there will be no additional funds to police the development until most of it is built.

In addition, the agreement makes no commitment to meet the premises needs identified by Leicestershire Police (and agreed by Blaby DC) at the time Planning Permission was granted.

Perversely, Blaby DC and the developer made timely provision for health coverage (triggered at 250 dwellings), and even for the improvement of Leicester City bus station [triggered at 50 dwellings] but did not see fit to agree something similar for safe policing.

There is also the real danger that the developer will only build 2500 houses with the result that no funds will be released for policing the development at all.

Question: *What has Blaby District Council done, or not done, to trigger this action?*

Answer: Blaby DC has a statutory duty to exercise its planning functions to achieve the proper planning of its area, under guidance from the Secretary of State which requires that it deliver adequate facilities to serve additional communities.

Its own Planning Policies make provision for developer contributions to Policing from this development.

Furthermore, under S17 of the Crime and Disorder Act, each Local Authority has a duty to exercise its various functions with due regard to the likely effect of those functions on, and the need to do all it reasonably can to prevent, crime and disorder in its area.

It is the Police view that the agreement entered by the Council and developer with regard to Lubbesthorpe does not meet these requirements. Sufficient and timely funding to ensure the safety of residents of the development is not yet secured – and in our view planning permission should not have been granted without this. This is at the heart of our action.

Question: *What would happen if you simply accepted the situation and not taken this legal course of action?*

Answer: Had the PCC, with Police and legal advice, not challenged the current situation there would be no extra financial provision (for infrastructure and facilities) until 2600 houses had been occupied – likely to be more than eight years into the project - according to the limited programming information we have been given. The development may even have stopped before this point with no funding for policing.

In effect, therefore, Blaby District Council and the developer are currently expecting Leicestershire Police to ensure the safety of a new community of around 6300 residents without any new funding for infrastructure. This is the equivalent of being asked to take on our statutory duty of care for an additional community, three times the size of the town of Uppingham, from within existing assets. When completed, according to the developer, Lubbesthorpe will be the same size as Market Harborough.

This would result in a dilution of policing in other neighbourhoods. As evidenced by the PCC's reluctant decision to raise the Council Tax Precept for the financial year 2014/15, we do not have 'spare' resources with which to take on this extra responsibility without detriment to the quality of policing within extant communities.

Question: *Will you challenge every planning application?*

Answer: We need to make sure, in the interests of safety of our communities, that every housing development has adequate provision for policing.

For instance, according to independent research, a development the size of Lubbesthorpe will need to be built in our police force area in each and every year for the next 15 years in order to meet housing demand. There are currently four similar growth point proposals in the Planning pipeline and many smaller Planning applications.

Faced with this number of additional households, and the 11,000 people that will occupy them each year, the situation regarding Police over-stretch would become untenable in regard to the safety of citizens.

We are trying to work co-operatively with all Councils in our area and, in some cases, with a good deal of success. It is unusual that our straight forward requests result in an imposed and inadequate outcome as in this case.. We cannot dismiss the possibility of having to use such a challenge in other cases. It is a last resort - but a necessary one if our communities are to be adequately Policed and when we are confronted by such an outcome.

Question: *Is this the first time a Police Force has challenged a local council in this way?*

Answer: It is the first time for this Force. Not only is this case incredibly important in its own right, but we need to make it clear to future developers (and the Councils who negotiate agreements) that they must make appropriate and informed provisions for Policing.

Nationally the Association of Chief Police Officers promotes Police involvement in the Planning process because they recognise the impacts that growth brings on the delivery of Policing. For example, Thames Valley, West Mercia and Warwickshire Police take similar approaches (with the latter just having secured a commitment from Rugby Council in relation to a similar sized development). The work of Leicestershire Police in this area is nationally recognised as best practice.

Question: *Will a finding in your favour as a result of the Judicial Review stop the development? Is it now just too late for anyone to do anything?*

Answer: We are not trying to stop the development. However, in the interests of public safety, we are seeking guarantees of the necessary financial provision for policing, which need to be in place before the development gets underway.

We do not believe it is 'too late' for the [Lubbesthorpe] development to go ahead as planned and on time provided Blaby District Council rapidly engages with the developers to ensure the necessary financial provision within the agreement.

We continue to invite this and we will review our action as soon as this happens.

Question: *What happens now?*

Answer: We would obviously like to see the matter satisfactorily resolved as quickly as possible. We have invited Blaby District Council and the developer to join us

in an independent mediation process and we hope they are able to commit to this to try and reach agreement. We believe this will be a mutually acceptable and positive way forward to avoid litigation.

Question: *If you get the funding will it mean that you will be recruiting more police officers?*

Answer: We have sought money for our additional capital costs eg for premises, vehicles, IT and Communications, CCTV and officer equipment and generally s106 funds are for such capital items. Additional council tax income generated from this development, together with our funds from the Home Office, will be used to fund additional officers and staff to deliver Policing to it.

Question: *Could the funding required for providing policing to this development not be met from reserves until the trigger point is reach?*

Answer: No. Reserves are held for a variety of potential unforeseen costs and liabilities but not those arising from housing and other growth related demand. There are rules that require us to maintain these reserves if we have to call upon them in emergencies. It would not be appropriate to use these public funds in this way – S106 makes it clear that infrastructure funding should come from the developer, not the taxpayer.

Question: **How much is this legal challenge likely to cost?**

Answer: The exact costs are not yet clear, and depend to a great extent on what happens next. On the other hand it is quite clear that if we did not take this course of action now, the eventual cost to the taxpayer in terms of policing would be prohibitive.

Question: *Has this action been prompted by the fact that Blaby District Council has been placed in 'Special Measures' by the Government because of its planning performance.*

Answer: We were aware of this. However because we have been making the Police case for a contribution from this development since late 2009 this announcement is unrelated to our action.
