NOTICE is given that from 22<sup>nd</sup> July 2015 to 18<sup>th</sup> August 2015 inclusive, between 9.30am and 4.00pm (Saturdays and Sundays excepted) any person interested may inspect, and make copies of, the accounts of both/either Office of the Police and Crime Commissioner for Leicestershire or Office of the Chief Constable for Leicestershire for the year ended 31<sup>st</sup> March 2015 and the books, deeds, contracts, bills, vouchers and receipts relating thereto. The accounts and other documents will be available for inspection at Police Headquarters, St Johns, Enderby, Leicester, LE19 2BX. Application should be made initially to Andrew Dale, Resources Manager / Deputy Section 151 Officer (telephone 0116 222 2222 or email andrew.dale@leicestershire.pnn.police.uk).

NOTICE is also given that on or after 17<sup>th</sup> August 2015 until the completion of the audit, the Auditor, at the request of any local government elector for the police area to which the accounts relate, will give the elector or his or her representative an opportunity to question him about the accounts, and that any such elector or his or her representative may attend before the Auditor and make objections as to any matter in respect of which the Auditor could take action under section 17 of the Audit Commission Act 1998 (namely, an unlawful item of account) or could make a public interest report in accordance with section 8 of the Act.

Questions may be received at Police Headquarters on or after 17<sup>th</sup> August 2015, at 10am or by arrangement with the Auditor, Richard Bacon, PricewaterhouseCoopers LLP, Cornwall Court, 19 Cornwall Street, Birmingham, B3 2DT, (telephone 0121 200 3000) to whom requests for this purpose should be addressed. The auditor (or his representative) will also be available on site at Police Headquarters to receive any question by appointment on 23<sup>rd</sup> July 2015 at 10am. No objection may be made unless the Auditor has previously received written notice of the proposed objection and its grounds. A copy of such notice must be sent to either the Chief Finance Officer, Office of the Police and Crime Commissioner for Leicestershire or the Finance Director, Office of the Chief Constable for Leicestershire at the address below.
