Successful Bids

Summary of Issue:

In his Commissioning Framework for 2017/18, the Police and Crime Commissioner set up a grant programme, named the Police and Crime Commissioner's Prevention Fund. The fund set aside £250,000 for 2017/18 and an indicative £250,000 for 2018/19 (an amount which was subsequently confirmed in the 2018-2021 Commissioning Framework which also gave indicative amounts of £250,000 for 2019/20 and £200,000 for 2020/21). The purpose of the Fund is to support the achievement of the objectives within the Police and Crime Plan.

The Prevention Fund is a rolling grants programme throughout the year and bid applications will be considered by the PCC on a monthly basis.

For any funding bids where a second years funding is approved, the second year funding is provided in principle subject to effective delivery and performance in year one.

During 2017/18 the PCC awarded 27 grants to a variety of voluntary sector organisations and exceeded his original budget spending £276,481 (the remainder being spent from the 2017/18 grants and emergent issues budget). Of the 27 grants awarded, 6 were awarded a 2nd years funding totalling £61,217 which is funded through the 2018/19 funding.

So as to ensure that a similar number of grants can be awarded during 2018/19, the PCC is topping up this years grant fund by the same amount (£61,217) which will be provided from the commissioning contingency fund.

Grants awarded- Round 9

During Round 9, the PCC received 3 bid applications. All applications were assessed in line with the Prevention Fund Grant criteria and on the 28.03.2018 the applications were presented to the PCC for consideration and final approval.

The PCC reviewed these applications together with the officers present and the PCC agreed to fund 1 of the bid applications from Round 9.

The PCC approved 1 bid in Round 9:

2018/19 - £8,900 (1 bid)

This equates to a further funding commitment for round 9 of £8,900 for 2018/19. The balance of the fund for 2018/19 (given the additional funding being added in by the PCC) is £241,100 and the total funding approved to date for 2018/19 is £70,117.22.

Grants awarded- Round 10

During Round 10, the PCC received 6 bid applications. All applications were assessed in line with the Prevention Fund Grant criteria and on the 28.03.2018 applications were presented to the PCC for consideration and final approval.

The PCC reviewed these applications together with the officers present and the PCC agreed to fund 2 of the bid applications from Round 10.

The PCC approved 2 bids in Round 10:

2018/19 - £16,330.50 (2 bids)

This equates to a further funding commitment for round 10 of £16,330.50 for 2018/19. The balance of the fund for 2018/19 is £224,769.50 and the total funding approved to date is £86,447.72 for 2018-19.
