# **Summary of Issue:**

The current Domestic and Sexual violence and abuse (DSVA) service is co commissioned by the Police and Crime Commissioner (PCC) Leicester City Council, Leicestershire County Council and Rutland County Council and delivered by a consortium (United Against Violence and Abuse (UAVA)) made up of three organisations; Freeva, Living Without Abuse and Women's Aid Leicester. The contract commenced in January 2016 and is due to end March 2021. Within the current contract, UAVA have a subcontracting arrangement with local providers to deliver therapeutic support services to victims. This area of provision has always been oversubscribed and in 2018 an initiative (through the Violence Against Women and Girls (VAWG) funding) sought to address some of these issues by undertaking a deep dive exercise and the recruitment of a therapeutic support coordinator, this work is due to conclude in March 2020. The Therapeutic Support Coordinator role was funded through the VAWG fund via a grant contract between the PCC and FreeVa.

Over the last 18 months co-commissioners have been working to redesign the whole domestic and sexual violence and abuse service model. The increased demand on therapeutic support for victims continues, additional monies have been allocated by the PCC (subject to a separate decision record) to three local subcontracted therapeutic support providers to try and alleviate some of this service pressure.

Co commissioners have collectively agreed to fund the Therapeutic Support Counselling Coordinator for a further 12 months to allow this role to continue and so that it aligns with the recommissioning and procurement timeline for the new service.

Co commissioners have agreed to funding as in the table below.
