# **Summary of Issue:**

The Commissioner has developed a Legacy Programme to take forward some of the most promising elements of his period in office. The overall theme of the programme is the prevention of harm with a particular emphasis on empowering communities to take responsibility for establishing harm-free environments

The Legacy Programme consists of all initiatives that the PCC has developed over his term of office, which continue beyond the end of his term. The items referred to below are those for which a financial commitment has been made.

For each item the cost commitment is highlighted:

Title	Description	Financial Commitment	OPCC resource to develop initiative
MUGA Courts	This is a collaborative project with a number of partners, including the Football Foundation/Premier League Leicester City in the community and Leicester City Council. It provides sporting facilities within local communities and a range of wrap around activities centred on the sporting facility but designed to stimulate community involvement more broadly.	2020/21 - £50,000 2021/22 onwards - £50,000	The only resource allocated at this point is a proportion of the Head of Communities and Partnership's time, up until the end of May 2021. Once the Community Development Worker is in post it will assume full responsibility for development.
