### Title: Contribution to MARAC (Multi agency risk assessment conference) 2022/23

## Summary of Issue:

Multi-Agency Risk Assessment Conferences (MARACs) exist to enable public bodies and their commissioned provision to best assess, manage and mitigate the risks faced by those victims within the highest risk domestic abuse relationships. In Leicestershire there is a single MARAC covering the force area and this has been on a remodelling journey since 2017/18. MARACs were originally set up with the support of SafeLives and have existed for many years now and are widely recognised as being a key feature of any local response to domestic abuse. In 2017/18 our approach to MARACs was to have a monthly meeting where the highest risk cases were discussed. With monies from the Violence Against Women and Girls (VAWG) Transformation fund the MARAC was developed from a single monthly meeting to weekly and eventually daily meetings.

This has enabled a much better approach to collectively tackling high risk domestic abuse cases and enables agencies to intervene at a much earlier stage after things have just escalated to a point of high risk for a victim. This shift to a daily approach was enabled through the funding of two additional posts within the force (in addition to an existing post already paid for by the force) who oversee/chair the daily MARAC and support the significant administrative burden that arises from this. During 2020/21/22 the costs of this re-modelling were met by the partnership and the PCC.

SafeLives were invited to undertake a critical review of the MARAC due the level of change the MARAC has undergone and as a result, the funding model has been updated to allow for additional development and capacity.

The PCC's contribution to the MARAC for 2022/23 is currently £20,000. It is proposed to increase contributions across the partnership to add capacity and the PCC's contribution to this would see an additional £8,700 for 2022/23.

Based on the above, the PCC's contribution to the partnership funding for 2022/23 would be £28,700. This is an additional £8,700 on the forecasted 2022/23 contribution amount but reflects a reasonable adjustment to meet the additional capacity requirement.
