## Freedom of Information Act 2000

I write further to your freedom of information request received on 29 May 23. I note you seek access to the following information:

The PCC has arranged for mobile camera surveyance on the B581 at Dunton Bassett following a complaint from a resident.

## Please provide:

- 1. Copies of the correspondence between the PCC & resident (resident's personal details redacted).
- 2. The date on which the PCC visited the location and for how long was he there
- 3. What equipment he used to measure the speed of the traffic and the results on which he based his referral to the police.
- 4. Copies of the PCC's recommendation to the police and any other body with regard to setting up the camera system.

The Leicestershire Road Safety Partnership insists that a number of prerequisites must be fulfilled before speed cameras (fixed or mobile) will be deployed. What evidence is there that the proper approval process has taken place for this location and that all the normal conditions have been fulfilled.

Your request for information has now been considered and the response can be found below:

1. Copies of the correspondence between the PCC & resident (resident's personal details redacted).

The Office of the Police and Crime Commissioner do not have anything recorded as being received.

We do not have access to the Police and Crime Commissioner's private social media accounts.

2. The date on which the PCC visited the location and for how long was he there

As part of the Police and Crime Commissioners Community Day the Police and Crime Commissioner visited the area on 18<sup>th</sup> May 2023

2. What equipment he used to measure the speed of the traffic and the results on which he based his referral to the police.

The Police and Crime Commissioner did not use any equipment to measure speed as this is an operational matter for the Force. Dunton Basset is a proactive mobile speed camera site.

The Police and Crime Commissioner did not make any recommendations to the Police or anybody with regard to setting up the camera.

What evidence is there that the proper approval process has taken place for this location and that all the normal conditions have been fulfilled.

The Leicester, Leicestershire & Rutland Road Safety Partnership comprises of Leicester City Council, Leicestershire County Council, Rutland County Council, Highways England and Leicestershire Police.
