Office of the Police and Crime Commissioner's (OPCC) Commissioning Framework 2024-25



Commissioning within the OPCC takes two major strands:

- Supporting victims and witnesses (including secondary victims) Statutory Responsibility
- Preventing crime and offending behaviours

The Police and Crime Commissioner (PCC) undertakes these responsibilities by way of Commissioning Activity within which there are a number of key contracted and granted services that are commissioned by the PCC, and within the commissioning cycle these fall into four categories:

- a. Those which have recently been re-commissioned and as such are already committed in the budget over the medium term.
- b. Those which are coming to the end of the contract/grant period and are currently undergoing review, or new services are being considered.
- c. Those where reviews are planned for the future due to contracts ending in the medium/longer term.
- d. Those projects which have been funded for a 12-month period and we have to consider sustainability.

This information is used to generate an ongoing schedule of review and scrutiny.

This paper gives an overview of LLR PCC commissioned and grant activity in the short-term (current financial year 2024-25) and medium term (beyond 2025) with reference to the areas of priority under which they funded and the source of allocated funding (Table 1). Areas of designated funding sit within the following priorities:

- Victim services
- Vulnerability
- Prevention
- Community Safety Community Safety Partnerships and Commissioners Safety Fund
- Partnerships

Long term committed activity:

Victim First -

Victim First is the PCC's statutory responsibility commissioned activity to provide support to victims and witnesses of crime and supports the force to meet their VCOP compliance (Victims Code of Practice - https://www.gov.uk/government/publications/the-code-of-practice-for-victims-of-crime-in-england-and-wales-victims-code) The service is provided by Catch 22 and was recommissioned in 2023 with a start date of 01/04/2024. The contract is commissioned for 5 years (3 plus 1 and 4 plus 1 contract breaks).

Victim Pathway Service -

£80,000 per annum was top sliced from the original victim services budget to provide a dedicated, force-led enhanced service to the most vulnerable victims and repeat victims. Funding committed to run alongside the main contract. Both services are funded through the MoJ Victims Grant.

Sexual Assault Referral Centres -

Funding for the Adult SARC @ Juniper Lodge secured to March 2028

Funding for the combined East Midlands Children's and Young Peoples SARC committed to March 2026, as a partnership agreement variation would need to be negotiated at a regional level.

Substance Misuse Services -

Funding contributions to substance misuse services ties into contracts held by the city and county councils to March 2026 with options to extend for one plus one years to 2028. The city and county contract services separately but have both contracted Turning Point as the provider.

Bereaved by Suicide -

Providing support to families/friends affected by bereavement by suicide. Contract is joint between the OPCC, the city and the county with the OPCC making the smallest contribution, the contract is held by Leicestershire County Council and delivered by the Tomorrow Project, commissioned activity agreed to 2028.

Medium term committed activity:

Helpline & Engagement Service -

Domestic Abuse support services provided by Freeva. Contract runs to March 2025 with options to extend for a further 2 years to 2027. Part of the success of the delivery of this contract is dependent on additional MoJ funding across both Freeva and multiple other agencies which runs to March 2025.

Sexual Violence & Abuse Service -

Support to victims of sexual violence and abuse provided by Freeva, works alongside the SARC delivery. Contract runs to March 2025 with options to extend for a further 2 years to 2027. Supplemented by MoJ grant funding to end March 2025.

PAVE/OCCD/DTOA -

Combined LLR delivery provided by Turning Point. PAVE – specialist outreach mental health support. OOCD – Specialist substance misuse out of court disposal activity. DTOA – Drug Test on Arrest in custody activity (DTOA is subject to a significant MoJ funding cut with the OPCC to utilise People Zone underspend to complete the three year project in Year 24-25). These combined commissioned activities contracted to March 2026 to tie in with main substance misuse contract break.

Partnership activity:

The OPCC contributes to multiple partnership activities which support the work of the OPCC, the force or the local criminal justice activity, these include:

- Children and Adults Safeguarding Boards
- Troubled Families programmes in the city, county, and Rutland
- Integrated Offender Management
- Youth Offending Services
- Multi-Agency Risk Assessment Conferences (MARAC)
- Domestic Homicide Reviews
- Crimestoppers

Annual commissioned activity:

Community Safety Partnerships - The PCC has a statutory duty to convene Community Safety Partnerships (CSP), funding to CSPs is however discretionary and to be agreed by the PCC. The PCC currently convenes nine CSPs across LLR, for the city, Rutland and each of the county districts. These are currently supported by a grant system year on year. Each CSP has funding directly proportional to their population size, crime rate and crime harm index with the city receiving the highest proportion and Rutland the lowest. Year 24-25 spend is £639,675.

Commissioners Safety Fund - The PCC can deliver a spend commitment to the Commissioners Safety Fund, the current spend is £400,000 per annum. This is discharged through grant rounds

by the PCC to problem solve, meet unmet need, meet emergent needs and are usually allocated in amounts less than £20,000.

Decommissioned Spend Re-profile - In the last financial year, the Target Hardening commissioned service was decommissioned, this spend is reprofiled for 24-25 to victim focused pilots, dependent on impact or direction this funding could be available in 25-26 but must be spent on victim services as it constitutes part of the MoJ Victims Grant.

Short term commissioned activity:

Victim services priorities -

The PCC received an MoJ grant to support specialist domestic abuse and sexual violence services, these grants end March 2025 and account for £435,000 value of specialist delivery. There is no indication that the funding will continue after March 2025 which poses a significant risk to domestic abuse and sexual violence capacity across LLR. These services are provided by a combination of:

- Women's Aid Leicester
- Living Without Abuse
- New Dawn New Day
- Catch 22
- Hope CIC
- Quetzal
- First Step LLR
- Leicester Rape Crisis

Prevention priorities -

DA Perpetrator Programme, provided by Freeva through the Jenkins Centre, funded via MoJ grant to end March 2025. Working across LLR to provide educational courses to domestic abuse perpetrators and additional support to victim/survivors. Annual cost £372,000, there is no indication that this funding will continue post March 2025.

OOCR; Out of Court Resolutions services – the PCC commissions three OOCR activities, outside of the substance misuse activity, these are:

- CARA (Conditional Cautioning and Relationship Abuse) delivered by The Hampton Trust, provides interventions for domestic abuse perpetrators referred through conditional caution and community resolution by the force. Provides additional telephone contact to victim/survivors. Contracted to March 2025 with an option for a one-year extension to March 2026.
- Women's OOCR Interventions delivered by New Dawn New Day, provides interventions to female offenders referred through conditional caution and community resolution by the force. Contracted to March 2025 with an option for a one-year extension to March 2026.
- Reflect, Young Male Adults Pathway delivered by Ingeus, provides interventions to male offenders aged between 18 and 25 referred through conditional caution and

community resolution by the force. Contracted to November 2024, extending to March 2025 to tie in all OOCR commissioned activity.

OOCRs are major initiative across criminal justice and as such across Leicestershire Police, this is an area where increased investment would yield impact post March 2025.

Warning Zone – schools activity centre, aimed at preventing future crime, delivered to Year 6 cohorts. Does not demonstrate impact. Contracted to March 2025 with an option for a one-year extension to March 2026.

Serious Violence Duty – funded to March 2025 to implement the Serious Violence Duty across LLR. No further funding post March 2025. Project will be completed.

Community Safety priorities -

Neighbourhood Watch Co-ordinator commissioned to October 2024

Safer Streets 5 – Three projects funded by the Home Office to meet the Round 5 priorities:

- Community safety and target hardening Oadby and Wigston
- Community safety and target hardening Melton
- VAWG Lead and initiatives for Under 25s across LLR

It is expected that the funding will cease as agreed March 2025.

Additional information:

The OPCC constitutes the entity that owns the Violence Reduction Network (VRN). Information pertaining to VRN commissioning activity is to be found in separate papers.

Hotspot Policing – the OPCC will discharge commissioning of grants provided to the force to deliver Hotspot Policing.

Immediate Justice – the PCC will be in receipt of Home Office funding to deliver an Immediate Justice programme from September 2024 to March 2025, funding is expected to be £500,000.

Commissioning outlook:

There is scope within the short term commissioned activity to provide some flexibility of longerterm commissioning options.

Investment in OOCRs will build upon the work started on a local and national footprint.

The disinvestment of MoJ funding for domestic abuse delivery will leave LLR at a significant disadvantage and will drastically reduce capacity in this vital area. Consideration could be given to decommissioning Warning Zone and Neighbourhood Watch, and alongside repurposing Commissioners Safety Fund budget to continue victim focussed commissioned services.
