In light of the current situation surrounding the COVID-19 pandemic the statutory audit deadline for 2020/21 for all local authorities in England (excluding the health service) has been extended. This is to give authorities more flexibility, time to adjust to new working practices and adapt to the changes faced in these unprecedented times. The date at which the annual accounts need to be published has moved from the 31 July to 30 September. The public inspection period must take place on or before the first working day of August 2021.

NOTICE is given that from 2 August 2021 to 10 September 2021 inclusive, between 10.00am and 4.00pm (Monday to Friday) any interested party may inspect, and make copies of, the accounts of:

- the Office of the Police and Crime Commissioner for Leicestershire; and/or
- the Office of the Chief Constable for Leicestershire; and/or
- the group accounts for the year ended 31 March 2020;

and the books, deeds, contracts, bills, vouchers, receipts and other documents relating to them. The accounts and other documents will be available for inspection at Police Headquarters, St Johns, Enderby, Leicester, LE19 2BX.

During this period a local government elector (or their representative) may question the auditor about the accounts or make an objection to the accounts as set out in sections 26 and 27 of the Local Audit and Accountability Act 2014.

Any objection, and the grounds on which it is made, must be sent to the Auditor in writing, with a copy to the Chief Finance Officer of the Police and Crime Commissioner and the Assistant Chief Officer – Resources of the Chief Constable at the addresses below.
