It is a statutory requirement to ensure there is a public inspection period of 30 working days. Due to the bank holiday in August it has come to our attention that the public inspection period for the 2021/22 accounts was open for 29 working days.

In order to comply with the statutory requirements NOTICE is given that from 4 November 2024 to 13 December 2024 inclusive, between 10.00am and 4.00pm (Monday to Friday) any interested party may inspect, and make copies of, the accounts of:

- the Office of the Police and Crime Commissioner for Leicestershire; and/or
- the Office of the Chief Constable for Leicestershire; and/or
- the group accounts for the year ended 31 March 2022;

and the books, deeds, contracts, bills, vouchers, receipts and other documents relating to them. The accounts and other documents will be available for inspection at Police Headquarters, St Johns, Enderby, Leicester, LE19 2BX.

Applications should be made initially to Kira Knott Chief Finance Officer (telephone 0116 2222222 ext 3307200 email kira.knott@leics.pcc.police.uk).

During this period a local government elector (or their representative) may question the auditor about the accounts or make an objection to the accounts as set out in sections 26 and 27 of the Local Audit and Accountability Act 2014.

Any objection, and the grounds on which it is made, must be sent to the Auditor in writing, with a copy to the Chief Finance Officer of the Police and Crime Commissioner and the Assistant Chief Officer – Resources of the Chief Constable at the addresses below.
