1. Purpose of Report

The purpose of this report is to provide the annual report of the Independent Custody Visiting (ICV) Scheme to the Strategic Assurance Board covering the period 1 April 2017 to 31 March 2018.

2. Recommendation

The content of the report is discussed and noted.

3. Background

Custody visiting in Leicestershire commenced in 1983 as a voluntary scheme following a recommendation from the Scarman report into the Brixton disorders in 1981. Section 51 (1) to the Police Reform Act 2002 placed independent custody visiting as a statutory function. The Home Office subsequently produced a Code of Practice on the delivery of schemes and National Standards were introduced by the Independent Custody Visiting Association (ICVA).

The Leicestershire Scheme was accredited with the Investing in Volunteers (IiV) award in October 2012, being one of only 3 schemes nationally to receive the award at the time. In October 2015 the Leicestershire scheme was reaccredited by National Council for Voluntary Organisations (NCVO) and is the only scheme in the region to hold this award.

In Leicestershire 27 Independent Custody Visitors (ICVs) visit 3 primary custody suites, being Euston Street, Keyham Lane and Beaumont Leys.

4. Visits undertaken 1 April 2017 to 31 March 2018

Independent Custody Visitors have the target to visit each primary custody suite, a minimum of one visit per week.

During 2017/18 a total of 152 visits were made as follows:-

Beaumont Leys	50 Visits
Keyham Lane	49 Visits
Euston Street	53 Visits

Euston Street and Beaumont Leys received one visit per week. Keyham Lane custody suite was closed for 3 weeks of the year from January to February 2018 due to refurbishment and therefore no visits were undertaken at this time.

5. Access to the custody suite

Of the 152 visits undertaken during 2017/18 immediate access to the custody suite was provided on 131 occasions, 19 visits incurred a wait of 6-15 minutes and only 1 visit incurred a wait of 16+ minutes. For those visits that did incur a wait for access, explanations were provided to the visitors at the time and in the main, the explanation was that the custody suite was busy and at the time a member of staff was not available to escort the visitors. On the one occasion when the visitors' access was delayed by 16+ minutes, the custody staff were dealing with a violent detainee at the front desk therefore access to the custody suite was delayed for the visitors' safety. On occasions where delays were incurred custody visitors were allowed immediate access to the custody suite and were allowed to view proceedings whilst waiting for a member of staff to be available.

6. Detainees seen, not seen or who refused a visit by Custody Visitors

During 2017/18 the total number of detainees through custody was 13,856

The total number of detainees in custody at the time of custody visits was 1092.

Of these:-

- 480 (44%) were offered a visit from Independent Custody Visitors.
- 567 (52%) detainees were not available to be visited, for a variety of reasons e.g. in interview, in hospital, out of cell, or asleep.
- 43 (4%) were not offered a visit for a variety of reasons e.g. advised by custody staff not to visit due to aggressive behaviour, intoxicated or other health concerns.
- 460 (96%) of those offered a visit agreed to be seen.
- 20 (4%) of those offered a visit refused to be seen.

7. Day and Time of Visits

To ensure a varied coverage of visits each week is divided into 35 timeslots for each custody suite. Over the year, apart from one time slot at Euston Street custody suite, visits were undertaken across all times of the day and days of the week. Unfortunately one slot was missed at Euston Street. A varied spread of visits is crucial to ensure that visits do not become predictable and occur at regular and set times. The performance during 2017/18 has been the best performance to date for coverage.

8. Issues raised by detainees and force response

The majority of the issues were reported from the custody visits were minor and two major issues were reported. A list of all issues raised in 2017/2018 can be found in *Appendix 2* of this report.

Major issues reported

• Beaumont Leys:

Detainee handed over a ligature to the ICVs which was made out of the edging of a towel

OUTCOME - The incident was recorded as an adverse incident and investigated. The ligature was not used as the detainee was unable to find a ligature point within the cell. The Inspector recommended that Custody Staff were advised regarding the removal of towels from detainees once used. There were no indications that the detainee was suicidal or had suicidal thoughts prior to the discovery of the ligature. He had seen a Health Care Professional four times prior to the ligature being discovered and saw one twice following the discovery.

• Euston Street:

Custody visitors spotted a nail on Cell 31's blanket which had been missed on search. Detention Officer removed item.

OUTCOME - Addressed at the time and followed up to ensure lessons learnt. All Response Staff and Custody Staff were emailed regarding the importance of thorough searching when arresting a suspect and when detainee arrived in custody. Staff also advised to ensure the search wand was utilised in custody.

An overview of issues reported on more than one occasion

• Beaumont Leys:

Visitors had noted on three separate occasions a number of drinking cups needed removing from cells.

OUTCOME - Noted, resolved and reminder sent out. This was reinforced at G4S training. Such items were removed periodically. The removal of cups would not automatically happen when detainees were asleep to save disturbance into their rest period. Items were often removed on request, or if they carried a risk, were unsanitary or when the detainee left custody. The force advised that it was expected that there would be some empty cups etc. in cells during a person's detention.

• Keyham Lane:

Drain blocked in exercise yard noted on two separate occasions.

OUTCOME - Force confirmed the drain was blocked with small debris from recent rain fall. Estates informed to unblock and clean yard floor to avoid reoccurrence. Drain blocked noted once again in February 2018, checked and cleared by Detention Officer – may have been blocked during closure.

• Keyham Lane:

Unpleasant drains smell noted on two separate occasions.

OUTCOME - Contractors have since been out 3 times. Now been out and found that rats had eaten through sewage vent pipes into loft space. All replaced. Additional odour control being installed.

• Euston Street:

Leak in exercise yard noted on two separate occasions.

OUTCOME - A drip from the guttering has been identified reported to estates and has now been repaired.

 Euston Street: Yellow phone outside the custody suite out of order, noted on two separate occasions.
 OUTCOME - A temporary phone was placed in reception when the phone was out of order. The phone has now been fixed and is in full working order.

Requests made at time of custody visit

As a region, Leicestershire, Northamptonshire, Nottinghamshire, Lincolnshire and Derbyshire use the grid below to log requests made at the time of custody visits. Leicestershire's Scheme Administrator is the representative for all scheme administrators within the East Midlands region at the East Midlands Strategic Custody Group and provides a quarterly report of requests made by detainees, within all custody suites in the region.

From conversations with detainees held in police custody the following requests were received at Leicestershire custody suites. All requests were reported to the Custody Sergeant with the majority being dealt with at the time of the visit:

9. Current custody visitors

At the start of April 2017 there were 29 ICVs. During the year two ICVs left. One left after 19 years of service due to no longer having the time to volunteer and one left after 18 years of service due to family commitments. Both ICVs were provided with the opportunity to meet with the PCC and receive a long service award for their commitment to the scheme. The current number of ICVs is now 27.

Comment	Response
So sad to be leaving but due to family commitments, I made the decision to leave. I enjoyed 18 years of service. I feel due to health and safety, there should be an upper age limit of 76 to be a custody visitor.	There is no upper age limit for ICVs and there is no reason to be. It would be discriminatory to reject people just because of age and hence the Home Office Code of Practice and National Standards do not recommend this. A risk assessment for the role is in place and is updated annually.
Relationship with Co-ordinator, OPCC and fellow custody visitors has been excellent, one team approach is better.	Feedback passed onto coordinator team and ICVs. The transition from three teams (one team for each custody suite), to one team of independent custody visitors that visit all three custody suites occurred two years ago and had been successfully implemented.
Very good training. Highlights different areas and gives broader experience. The quantity of training is right and at the right level.	As well as induction training, refresher training is available to all independent custody visitors to ensure their knowledge is up to date and other training sessions are provided to broaden their knowledge. Last year a Suicide Awareness training session was provided and was well received by the custody visitors.
Grateful to the Deputy Coordinators that helped out and thank you to all the staff.	Feedback passed onto the Deputy Co-ordinators and staff.

Feedback from exit questionnaires was received as follows:

No negative comments have been received by custody visitors leaving the scheme.

10. Meeting with Co-ordinators

The Volunteer Manager met with Co-ordinators and the Force Custody Inspector on 1 June, 31 August, 29 November 2017 and 1 March 2018. The main items discussed and outcomes were:

• ICV Translation Sheets:

They include set questions of rights and entitlements in 22 different languages and can be used to check that the rights and entitlements of Non-English speaking detainees at custody suites are being met. They are used by three schemes within the East Midlands, being Derbyshire, Nottinghamshire and Northamptonshire. The Leicestershire scheme agreed implementation in January 2018.

- Changes in legislation: Mental Health Act 2017 amendments. ICVs were updated on the changes and received a training session from the Volunteer Manager at an ICV team meeting.
- Female sanitary protection in custody. Agreed that independent custody visitors could ask detainees if they would like to speak to their allocated female officer/staff.
- Introduction of spitguards: Independent Custody Visitors were updated on the rollout of spitguards. Spitguards covered the nose and mouth area of detainees that spat at police officers or staff.

11. Developments during 2017/2018

- PCC Lord Willy Bach observed an independent custody visit on Volunteers' Week in June 2017 and appreciated all police volunteers. The full Leicester Mercury article on Lord Bach's custody visit can be found on *Appendix 1* of the report.
- PCC Lord Willy Bach is now an appointed External Director on the board of directors for Independent Custody Visiting Association (ICVA). It is hugely beneficial to the Leicestershire ICV scheme to have the PCC on the board and assist with implementing improvements to custody visiting nationally.
- ICVA introduced and supported schemes to deliver bitesize training sessions. A recent bitesize training delivered by the Volunteer Manager was the changes to the Mental Health Act 2017.
- ICV Translation sheets were introduced in January 2018 as a tool to assist ICVs in communicating with Non-English speaking detainees.
- ICV Risk assessment was reviewed and updated.
- A data log of total number ICV volunteer hours was introduced. The total number of hours ICVs have spent on custody visits during 2017/2018 was approximately 280hours. This equated to an average of 1hour 51mins per visit (including travel time to and from the custody suite).

12. Future Development

ICV Custody App

Leicestershire ICV scheme is in the process of implementing an electronic ICV Visit Report Form – "ICV Custody App" for use on a tablet device at custody suites. The purpose of this 'webform' is to provide a platform for electronic recording of custody visits. The webform will be accessible via a tablet device available at the 3 primary custody suites, Beaumont Leys, Euston Street and Keyham Lane. The software will be supplied by a company called Police Commissioner Solutions. Early discussions with the procurement team are taking place to seek advice on Single Source Dispensation (SSD).

The approximate timescale for implementation is as follows:-Training to take place September 2018 Parallel testing phase from October to December 2018 Go live date in January 2019

Purpose and aim of the ICV Custody App

The ICV Custody App has the ability to record all aspects arising from a custody visit. The introduction will increase efficiency and be used as an effective way of processing and managing Independent Custody Visits. The app will provide secure access via a force approved tablet device to both ICVs and admin personnel, including the ability to manage custody reporting, rota management and generate comprehensive reports based on the data collected. Regional colleagues in Derbyshire, Nottinghamshire and Northamptonshire have implemented the ICV Custody App and have provided excellent feedback. Lincolnshire also considering implementation.

Recruitment

An independent custody visitor recruitment campaign will commence in September 2018 to recruit 10 independent custody visitors. The last recruitment campaign for custody visitors was in June 2015 and 9 independent custody visitors were appointed. This will help to provide resilience with covering custody visits and with targeted advertising to improve upon the diversity of the team of independent custody visitors.

13. Regional Collaboration

Scheme Administrators in the East Midlands have met on the following dates; 4 April, 22 August, 7 November 2017 and 8 February 2018. The meetings provided an opportunity to share good practice. Items addressed included:


There are 27 current independent custody visitors. The demographics of the custody visitors are:-














15. Positive feedback from ICVs to Custody

16. Conclusion

It has been an excellent year for visits with a total of 152 visits compared to 145 visits last year. There was 100% coverage of time slots at Beaumont Leys and Keyham Lane and 97% coverage of time slots at Euston Street custody suite. Meetings with Co-ordinators and custody Inspector Phil Tompkins have been extremely constructive and have given the OPCC a chance to discuss future developments set out in this paper. Lord Bach being on the Independent Custody Visiting Association Board of Directors is an effective mechanism for Leicestershire to lead upon national improvements to custody visiting.

Implications

Financial: None

Legal: It is a statutory requirement to have a Custody Visiting Scheme in place under Schedule 16, part 3, paragraph 299 (i) of the Police Reform & Social Responsibility Act 2011.

Equality Impact Assessment: The ICV scheme is constantly monitored to ensure those involved in the scheme are representative of the local community.

Risks and Impact: Link to Police and Crime Plan: The maintenance of the ICV Scheme is a statutory requirement of the PCC Role.

Lord Bach paid a surprise visit to the Euston Road police station custody suite, in Freeman's Common, Leicester, with independent custody visitor Justin Hammond.

Speaking as the country marked National Volunteers Week, he said the commitment and dedication of those who gave their time to help the police was inspiring.

"Volunteers bring so many benefits to policing in so many different ways," he said. "From Special Constables to

The ICV scheme is led by the police and crime commissioner and has 29 members.

The visitors, who are all independent, make unannounced visits to police stations across Leicestershire and Rutland to check on the treatment of detainees, the conditions in which they are held and that their rights and entitlements are being observed.

"There is no better scrutiny system than one where members of the public themselves carry out the appraisal," said Lord Bach.

"Our ICVs provide an impartial and independent check to reassure us all those detained Lord Bach in custody are looked after

to thank them for their com- properly, in decent conditions and in accordance with all their legal rights and entitlements.

"Most of the feedback we receive following visits is very positive and where any small issues are identified by our detainees, these are dealt with and resolved very swiftly.

"But these visits also offer a protection mechanism for both the prisoner and the custody officers.

"If a complaint has been made we can help discover if it is genuine or not, saving time and stressfor all concerned."

			Custody officers should monitor detainees' food and fluid consumption to ensure that their welfare is maintained. Officers conducting visits and providing meals should inform the custody officer immediately if any detainee appears to be eating or drinking so little that it may affect their wellbeing. A HCP should see the detainee in these circumstances and concerns should form part of the handover between custody officers.

Sanitary consumables are either tampon, sanitary towel and a disposable paper bag for sanitary wear for disposal purposes. We also have disposable pants too (3 sizes). Sanitary wear can be issued by <u>any</u> member of staff. All females in custody are allocated a female officer (that will be a detention officer if on duty) if not it will be an officer from elsewhere in the force but is allocated. This means the detainee can ask to speak with the allocated female officer if requested. All female detainees are informed at the time of booking in, that they are able to speak with a female officer (detention officer/police officer) at any time during their stay. We do not ask the direct question if a person is on their menstrual cycle as often custody suites can be very busy and not very personal. If it is necessary for a female detainee to be on a CCTV constant this is carried out by a female.
		Nobody views screens to cells unless doing an observation H & S check of person. Lastly I am looking into providing a slightly wider range of products that female detainees may find more suitable for them. Once stock has arrived I will ask our custody staff to be more active around how provision is offered giving detainee more options to choose and put emphasis on the hand washing facilities at our older stations.
