Title: Hinckley Police Station

Summary of Issue:

The sale of the Hinckley Police Station has become a protracted matter because of the purchasers (the Suyuti Institute) inability to complete the staged payments following the initial payments in November of last year. To date, the sum of £315,000 has been paid out of a total of £360,000 plus legal fees. In order to bring this matter to a conclusion as soon as possible, it is proposed, with the benefit of legal advice from Harvey Ingram Shakespeares, that legal completion of the sale is now effected with the sum of £45,000 still outstanding but with Leicestershire Police having a first charge on the property until the outstanding sum is paid. In this way, all current and future liabilities will rest with the purchaser, it would enable the purchaser to raise finance on the building and the money currently in our solicitors client account could be released to us.

Recommendations presented:

It is proposed, with the benefit of legal advice, to complete the sale of the Hinckley Police Station on the basis as set out above in the Summary of Issue.

Key discussion points at meeting

It is appropriate to bring this sale to a swift conclusion, and this transfer will facilitate this.

Legal advice has stated that this is a low risk tactic for Leicestershire OPCC as there will be a charge on the property.
