Title: Purchase of Discreet Building to support Regional and National Collaboration

Summary of Issue:

Following national funding provided in 13/14 and made available in 14/15 to the East Midlands Regional PCC's, to purchase an additional discreet building within the region for relocation of existing 5 force collaborative resources. This would enable co-location with the National Crime Agency, in line with the national and regional strategy and which is a natural extension of joint approach to crime collaboration in the East Midlands.

Recommendation(s) presented:

That the Police & Crime Commissioner:

- Approve the purchase of the discreet building together with East Midlands PCC's at the net purchase price of £700,000.
- That the purchase and associated conversion costs of the existing and new discreet buildings be met from the national funding provided.

Key discussion points

This was discussed by the Regional PCCs on a number of occasions since May 2014, including the options. A number of further meetings have explored these options and costs and agreement given by the Regional PCCs at their meeting on the 17th June 2014 to purchase the discreet building, to be met from the national funding allocation provided and for conversion and adaptations to be within clear criteria. A regional PCC representative is present at the project Board meetings to provide oversight and input from a PCC perspective.
