Title:	Sale of Syston Police Station

Summary of Issue:

In line with the Estates Strategy and the Implementation of the force's change programme "Project Edison", the force has recommended that Syston Police Station, within the Charnwood District, should be earmarked for sale.

Various options were considered by the force's Change Board but it was agreed that the property, which has been used as a Police Station for in excess of 15 years, could be released.

Under the current Force structure there are two LPU's within the Charnwood District and under Project Edison these will merge into one Neighbourhood Policing Unit under the command of one inspector.

The building has not been formally valued but it is understood that its value is likely to be in the region of £250,000. The annual savings to the Force following its sale will be around £25,000.

Recommendations presented:

It is recommended that Syston Police Station should be sold on the open market as outlined above with savings incorporated into the force revenue budgets.

Key discussion points at meeting

The PCC highlights the need for the force to ensure that appropriate engagement with local stakeholders takes place and to receive assurance from the force on this engagement and an update on possible beat office locations prior to the sale of Syston.

It was resolved that :

The Sale of Syston be agreed in principle with the need for the force to ensure that appropriate engagement with local stakeholders takes place and for the PCC to receive a report on assurance from the force on this engagement and an update on possible beat office locations prior to the sale of Syston.


