Title: Victim First contract extension

Summary of Issue:

The Victim First contract was set up with a 26 month contract awarded to Catch 22.

The contract current end date is 30th September 2017.

The PCC has started the process of considering and designing the replacement provision prior to either implementing this in-house or procuring this from an external organisation.

The timescales are now such that, if a decision was taken to go out to procurement, the OPCC would require a minimum of 9 months to action and implement the service.

To this end, it is recommended to offer a 6 month extension to Catch 22 (to end on the 31st March 2018).

This 6 month contract extension would provide sufficient time for the PCC to consider the in-house and procurement options and determine and implement the preferred option in line with proper procurement processes.

Appendix 1 (exempt from publication) sets out the legal rationale for the 6 month extension.
