Title: Provision of housing for victims of modern slavery

Summary of Issue:

Victims of Modern Slavery who come to the attention of the police are short term safeguarded and assessed for acceptance into the National Referral Mechanism (NRM). There is a short period until NRM safe housing can be arranged and this sometimes results in hotel accommodation being used.

Once accepted into the referral process victims are often relocated quite a distance from Leicestershire. A local facility will allow opportunities for victim statements to be completed by Leicestershire Police before victims are relocated, reducing investigation time and costs in travelling.

Recommendation(s) presented:

The Bishop of Derby had proposed the lease of a residential property for 12 months at a cost of £1 and in addition an estimated £5000 in costs to provide Gas, Electricity, Insurance, IT facilities and general wear and tear costs.

Key discussion points

The benefits of leasing accommodation for the short term provision of housing to victims of modern slavery are:

- Improved victim services and positive experience
- Reduction in police officer abstractions
- A unique facility in the East Midlands

It was resolved that:

- The PCC has entered into an agreement to lease a property from The Bishop of Derby (Chair of the Independent Anti-Slavery Commissioners advisory panel.) at £1 for contractual term of 12 months (from date of lease signature).
- The property will be used exclusively to accommodate and safeguard victims of modern until they are assessed for acceptance into the National Referral Mechanism.
- Leicestershire Police shall inform statutory partners of the new facility.
