**Title:** CLAIM FOR FINANCIAL CONTRIBUTION

### **Summary of Issue:**

Until 1994, arrangements for insurance for Leicestershire Police were made by Leicestershire County Council (LCC). The insurance was placed with Municipal Mutual Insurance Company until 1992.

By an agreement dated 22 December 1995 and made pursuant to the Police and Magistrates Courts Act, the liabilities of the LCC in this regard passed to the then Police Authority.

In 1992, Municipal Mutual Insurance encountered financial difficulties and entered into a Scheme of Arrangement with its creditors, with provision for a levy on all former policyholders to assist in meeting the financial obligations of MMI.

Under the terms of the 22 December 1995 agreement, the PCC (as statutory successor to the Police Authority) and Council have agreed that the PCC should contribute the sum of £200,000 towards the sums paid by the LCC in respect of the levy imposed in relation to police claims and 50% of any future levy in relation to such claims. This agreement has now been recorded in a settlement agreement.

The one off settlement has been provided for within the 2016/17 accounts and future costs will be met from the insurance reserve.
