Title: Police and Crime Commissioners (PCC) Prevention Fund – Round 13 Successful Bids

Summary of Issue:

In his Commissioning Framework for 2017/18, the Police and Crime Commissioner set aside funding for a two year grant programme, named the Police and Crime Commissioner's Prevention Fund. The fund set aside £250,000 for 2017/18 and £250,000 for 2018/19. In the Commissioning Framework for 2018/19, the Police and Crime Commissioner has identified a further £250,000.00 for 2019/20.

The purpose of the Fund is to support the achievement of the objectives within the Police and Crime Plan.

The Prevention Fund is a rolling grants programme throughout the year and bid applications will be considered by the PCC on a monthly basis.

For any funding bids where a second years funding is approved, the second year funding is provided in principle subject to effective delivery and performance in year one.

Grants awarded- Round 13

During Round 13, the PCC received 5 bid applications. All applications were assessed in line with the Prevention Fund Grant criteria and on the 27.09.2018 the applications were presented to the PCC for consideration and final approval.

The PCC reviewed these applications together with the officers present and the PCC agreed to fund 4 of the bid applications plus 1 bid application a from previous round.
