Title: Pro- Active Vulnerability Engagement (PAVE) Team Mental Health Provision- Turning Point

Summary of Issue:

The Police and Crime Commissioner agreed to fund PAVE in 2018/19-20 (PAVE was previously one of the Strategic Partnership Development Fund (SPDF) work streams).

There are two contracts which cover the PAVE service, a contract with Leicestershire Partnership Trust (LPT) and a contract with Turning Point.

This decision record relates to the Turning Point contract which was previously funded from the SPDF underspend. This funding allowed the contracting period to run from 1st October 2018 to 30th September 2019.

The PAVE service has been subject to a review and there is now a requirement to extend the Turning Point contract for a further 6 months to allow the service review to be completed and for the contract to align with the PAVE LPT contract.

Recommendation(s) presented:

- Agree to extend the contracting period from 1st October to 31st March 2020. The current contract has an extension clause built within it.
- Agree to fund this 6 month period from the Commissioning reserve.
 The cost of funding this 6 month period will be an additional £15,000.
