ESN earliest roll out is estimated to be January 2022. Highly likely to be delayed further.

Sepura no longer make handsets currently used by Leicester. 450 devices per year sent for repair per year at a cost of £135 each. £60,750.00. This will soon cease.

424 (old) airwaves in reserve, but cannot be repaired

Sepura making a new device from now to Dec 31st 2019 from £525 to £345 per device, should be suitable for ESN.

Request is to buy 500 new devices total cost £172,500.00 plus accessories totalling £75,000.00. This will be a saving of £90,000.00 on full price, to give resilience until ESN.
