Title: Domestic and sexual violence and abuse service/s - recommissioning

Summary of Issue:

The Police and Crime Commissioner (PCC) for Leicestershire currently contributes to a pooled fund with Leicester City Council, Leicestershire County Council, and Rutland County Council to fund a domestic and sexual violence and abuse service across Leicester, Leicestershire and Rutland (LLR). Leicester City Council hold the contract with the provider (United Against Violence and Abuse (UAVA)) which is due to end in April 2022.

The Police and Crime Commissioner for Leicestershire, Leicester City Council, Leicestershire County Council and Rutland County Council have been working together to re-design and recommission a new domestic and sexual violence and abuse support service, the detail of which can be found within appendix 1.

As set out in the Domestic and sexual violence and abuse decision record dated 5th May 2020, the total PCC funding available to recommission the new service is made up of a number of different current service elements and this adds up to a total PCC yearly contribution of £662,068 with partner contributions shown in appendix 1.

The re-commissioned model builds on the current service and the lessons learned in commissioning, procuring and contract managing an LLR wide service. The co-commissioned service is underpinned by a partnership agreement. The partnership

agreement details which commissioning party is funding, procuring and contract managing specific part/s of the service system; this detail is subject to a separate briefing paper shared previously.

This decision record draws out those key elements which are most significant for the Police and Crime Commissioner and makes recommendations that these are considered and approved.

Recommendation(s) presented:

In taking a co-commissioned approach, the PCC agrees to:

- 1. Fund (as set out in appendix 1), procure and contract manage two of the commissioned services directly, these are The Helpline and Engagement service and the Sexual Violence service.
- 2. The contract term being 3 years + 2 years
- 3. Commit current funding levels (£662,068) for the first 3 years of the contract term (which reflects the PCC commitment within the commissioning medium-term financial plan 2021/22)
