Title: Lived experience – Female offending

Summary of Issue:

The National Probation Service (NPS) together with The Office of the Police and Crime Commissioner (OPCC) have been working together to take forward a multi –agency and system wide approach to female offending. As part of this work a multi-agency steering group chaired by the OPCC (Paul Hindson) and NPS has been formed which aims to drive a local offer of systemic change for women in the criminal justice system. Key to the success of this workstream has been the inclusion of the service user and lived experience voice throughout the initial period of implementation. Lived experience was a significant part of the Female Offending Strategy 2018 launch event (which took place on 5th November) and has been identified by those who attended the launch as one of the significant factors in developing and driving this work forward. The Female Offending Strategy 2018 also makes reference to and the importance of lived experience not only within the policy but how it has been used by other lead agencies.

The intention of this workstream is to recognise and utilise lived experience using a co-productive methodology to ensure that whatever products are delivered through the implementation of this local programme that they are shaped and informed by the views, experiences, the needs and wants of women in the criminal justice system.

It is our intention to use "experts" from the community to help us shape and deliver a sustainable and community owned (i.e. allowing the community to influence and realise the benefits of) a lived experience co-productive model.

What work is required?

The OPCC and the National Probation Service are seeking to engage and commission a Facilitator to undertake this work on our behalf. There are a number of strands to this brief, there will be a period of scoping and consultation then implementation and delivery and finally evaluation and embedding. The intended timeframes are within 2021 - 2022, this will be a 1-year pilot with an available budget of up to a maximum of £20,000pa (£10,000 each from the OPCC and the and the National Probation Service) It is our intention to procure this service via Blue light and as such we shall be seeking from interested parties fully costed quotes as to how the brief can be resourced and implemented.
