**Title: People Zones Funding Allocation** 

#### Summary of Issue:

The Police and Crime Commissioner for Leicestershire has allocated £32,000 from the Commissioning budget to fund projects/programmes or initiatives within the three current People Zone areas. The purpose of the funding is to support the achievement and objectives of the People Zones areas: Bell Foundry, New Parks, North West Leicestershire. The funding is available for the 2021/2022 financial year.

The money will be broken down as below:

- £30,000 for anyone living or working within one of the three current People Zones to bid into to support projects or initiatives.
- £2,000 for Community Payback materials within the People Zones.

The OPCC are working in partnership with Probation and the Community Payback team to improve areas within the People Zones, by ex-offenders giving back to their communities. Probation will be supplying the service users and tools, however materials for the project will be funded by the PCC.

Anyone living or working within a People Zone area are able to bid into the People Zone pot via the People Zone application form. The form and guidance for applicants has been developed by the Community Development Officer and the Commissioning Team. The criteria for applications is as below:

- Engage the community and local people to encourage community spirit
- · Reduce crime, anti-social behaviour, serious violence or knife crime.
- Reduce health issues within the community
- Improve employability prospects within the community this can include: jobs, education, volunteering, training or work experience
- Improve sports services within the community
- Improve youth services within the community
- Improve mental health and wellbeing within the community
- · Adopt intervention initiatives that follow the trauma-informed approach

Applications -need to sent in the first instance -to Jessica Ball where they will be -evaluated -by the OPCC and reviewed by the PCC for a final decision.

Outcomes and outputs will be monitored by end of project reports required from the applicant, and data from the performance team based on the above criteria.

All bid applications were discussed in detail with the final decision on all bids made by the PCC.
