Title: New Parks People Zone Funding Application

Summary of Issue:

The Police and Crime Commissioner for Leicestershire has allocated £30,000 from the Commissioning budget to fund projects/programmes or initiatives within the three current People Zone areas, the purpose of which is to support the achievements and objectives across all the People Zones areas. This includes investing in building community and providing interventions which will support parents, children and young people to achieve and make positive choices thereby creating a bedrock from which the community safety objectives of the PCC's Police and Crime Plan can be achieved in those specific communities.

The PCC has received and considered an application for projects in the New Parks People Zone area and has agreed to fund, as set out in Table 1. below.

Team Hub		
Games Room	Through an already established Youth Forum, it was revealed that the young people would like a games room at the Hub. By being given this funding, it will show that staff have listened to the young people's voice and that they believe in them. This project will give the young people a sense of pride and the knowledge that by working together, change can be made together and they can make better choices in the community. It will also breakdown the barriers on the negative behaviour towards the police, by showing them that more can be achieved by	£4,079.95

	working together than against each other and builds up that relationship. It will also give them chance to take ownership of the gaming room, making sure everyone respects the room and doesn't damage or steal the equipment, giving them skills for the future and showing that working hard does pay off. This will also give another day of the week, a free activity for the young people to get involved in and engage with positive role models.

The total sum approved for is £4,079.95. A number of other applications have already been approved (£25,948 has already been allocated) this therefore results in an overspend of £27.95 which has been approved by the Police and Crime Commissioner.
