Title: Thringstone and Whitwick People Zone Funding Application

## **Summary of Issue:**

The Police and Crime Commissioner for Leicestershire has allocated £30,000 from the Commissioning budget to fund projects/programmes or initiatives within the three current People Zone areas, the purpose of which is to support the achievements and objectives across all the People Zones areas. This includes investing in building community and providing interventions which will support parents, children and young people to achieve and make positive choices thereby creating a bedrock from which the community safety objectives of the PCC's Police and Crime Plan can be achieved in those specific communities.

The PCC has received and considered an application for projects in the Thringstone & Whitwick People Zone area and has agreed to fund, as set out in Table 1. below.

Table 1. Funded projects

Project/initiative	Brief	Funding £
Kicking Boredom Into Touch	To target growing ASB within the community, petty vandalisms and to help give the younger people in the community something to do as there is precious little for younger people to do in the area.	£2,800

The total sum approved for Thringstone and Whitwick is £2,800. This is the first application to be submitted and subsequently approved, therefore leaving a balance of £27,200.

All bid applications were discussed in detail with the final decision on all bids made by the PCC.
