Title: CONT045 Supply and fit of tyres and associated products and services for Blue Light

#### **Summary of Issue:**

Procurement are looking to award the supply and fit of tyres and associated products and services contract from 1<sup>st</sup> October 2022 to 30<sup>th</sup> September 2025 for a maximum value of £360,000.

#### **Background**

The current contract has expired and the spend is as follows:

2021 / 2022 - £64,350.49,

2020 /2021 - £111,694.67,

2019/2020 - £105,356.41.

Crown Commercial Service (CCS) has award a lot on framework RM6142 Supply of Tyres, Glass and Fast Fit Solutions for the supply and fit of tyres and associated products and services to Blue Light Emergencies Services, which has been awarded to Goodyear Dunlop Tyres UK and to which the Home Office has recommended Police Forces use.

#### **Tender Process**

This is a direct award to a single supplier, Goodyear Dunlop Tyres UK. The tender process is as follows:

As part of the framework competition undertaken by CCS, they assessed the suppliers' technical, professional and financial capabilities in the selection stage of the tender process. All framework suppliers have evidenced that they comply with the following:

- Cyber Essentials basic scheme accreditation;
- financial Standing (Dun & Bradstreet threshold score);
- Lot 1 = Score 55 or above
- all Environmental, Health and Safety and Sustainability Standards set out in Public Contracts Regulations (PCR) 2015;

- public liability insurance certification (£1m);
- employer's liability insurance certification (£5m); and
- product liability insurance certification (£1m).
- Driving for Better Business All Suppliers must be signed up to the Driving for Better Business programme and show how they are progressing through the steps throughout the lifetime of the Framework.

### Award criteria for framework suppliers

The award criteria used for the framework competition was based on the most economically advantageous tender (MEAT) and was defined in the contract notice as 60% quality and 40% price.

The award was specified and evaluated by Police Fleet Managers to ensure it meets the needs of the Blue Light Sector.

#### Recommendation(s) presented:

I recommend that we award the supply and fit of tyres and associated products and services to Goodyear Dunlop Tyres UK for a maximum value of £360,000 over the full proposed contract period of three years from 1<sup>st</sup> October 2022 to 30<sup>th</sup> September 2025.

Andrew Parkes, Interim Head of Fleet and Paul Dawkins, Assistant Chief Officer (Finance & Resources), have agreed to award the requirement to Goodyear Dunlop Tvres UK
