Title: CONT0202 Handheld Airwave Kits

Summary of Issue:

Procurement are looking to make a direct award to Sepura Limited for 2,200 x Handheld Radio Bundles, 4,400 x Accessories and 2,200 Licence Packs using the Police Digital Service (PDS) Airwave framework and due to the value require PCC contract signature and sea the contract.

Background

The recent announcement by ESN to delay the project for at least 3-years leaves the Force with the challenge of maintaining officers and staff radios. The existing fleet of radios will not last that long and the Force will have significant challenges simply dealing with continual defects and moving old and new radios around the force to keep officers and staff operational.

The current PDS framework which guarantees radio prices expires 14th November 2022 and it is anticipated that prices will increase significantly thereafter.

The Force therefore need to procure new handheld airwave radios using the existing PDS framework urgently.

Tender Process

The PDS framework allows for a direct award where we are able to identify the most economical advantageous supplier without conducting a further competition and we have received further advice from PDS as follows:

"Direct award the Framework only requires a force to determine that the business need can be met by the available Framework Catalogue (including Price Drop) and the Call-Off Terms and Conditions do not require material amendment. If you can meet these two requirements, the risk of challenge, and that challenge being successful, is considered low by PDS.

In your case Leicestershire are buying standard product off catalogue from an existing technology provider on (i) value for money grounds i.e. cost of change, a switch to Motorola would require a full radio fleet swap out and (ii) system interoperability issues of running a mixed Sepura / Motorola fleet."

IT have received approval from Paul Dawkins, Assistant Chief Officer (Finance & Resources) and Rupert Matthews, Police and Crime Commissioner to buy the equipment and licences.

Sepura have quoted a price of £1,378,998.00

Recommendation(s) presented:

I recommend that we award a contract for Handheld Airwave Kits to Sepura for a price of £1,378,998.00
