Summary of issue In March 2020 the lease of premises at Bruntingthorpe Aerodrome was	
renewed for a three year period with the landlord and owner of the aerodrome Cox Automotive Ltd at an annual rent of £21,000 per annum. Because that lease will expire in March this year, negotiations have been ongoing in respect of a renewal of such lease. Accordingly, terms have now been provisionally agreed for a new lease for a further three years at an annual rent of £23,100 per annum commencing in March this year. The new rent represents an increase of 10% compared to the existing rent and is considered to be acceptable in relation to the current market for commercial properties over a three year period. The remainder of the terms of the lease are unaltered.	
The property is still required for policing	g purposes.
Recommendations presented: It is recommended that the provisionally agreed terms, as outlined above, for the renewal of a lease at Bruntingthorpe Aerodrome are approved.
