Title: Oracle Shared Licences

Summary of Issue:

The Force requires new Oracle licences, which include a shared (between Force) capability as the old licences are no longer valid. We are procuring by direct award using the Crown Commercial Service RM6194 Back Office Software framework and are asking the Police and Crime Commissioner tosign / seal the Oracle ordering document.

Background

Oracle inform us that the licencing model was no longer available and where Oracle Licences were shared by other forces there would be additional costs. We took Legal Services advice and they said that if we wanted to continue using the licences, we would have to pay the extra charge.

After consulting with IT, Oracle have submitted a new quote for the licences with the extra charge and it has been agreed to procure by direct award using the CCS RM6194 Back Office Software framework.
