Title: People Zones Round 1 Thringstone & Whitwick Successful Bids

Summary of Issue:

People Zones are locations with a boundary attached, that has been identified through crime and public health data. People Zones follow an Asset Based Community Development approach, which focuses on highlighting what assets are in the area and how we can help communities to build upon and enhance them. The hope is to empower residents and workers to work collaboratively to become a stronger, safer, and self-sustaining community.

To be eligible to apply for People Zone funding, applicants must be living, working, or providing a service within a People Zone, and the project must meet one or more of the themes identified within the People Zones research report. This decision relates to the second round of funding of 2023, ring fenced for the Thringstone & Whitwick people zone.

The Thringstone & Whitwick funding round opened on 27/02/2023 and closed on 27/03/2023. 4 applications were submitted during this time. Community Development Officers Lily Thorne and James O'Connell individually marked each application during the period 28/03/2023 – 03/04/2023, and then moderated their scores on 04/04/2023 under the supervision of Kaitlin Trenerry, Commissioning and Contracts Officer.

All 4 applications were approved by the PCC - this equates to a funding commitment of £14,197.00

| Whitwick Scouts Group | Scout & DofE Awards | A key part of both Scouting and the Duke of Edinburgh Award Scheme are the Expeditions where lifelong memories are made, along with significant life skills learnt in the weeks of training leading up to their expeditions. However, without access to the right equipment, the group are limited to what they can offer, especially for the older 14 to 25 age ranges, who demand more adventurous, challenging and involved programs and activities. This Project will expand the older (14 – 25 years) youth provision in new and exciting ways, by providing the necessary equipment to support top Scouting awards and a new initiative of Duke of Edinburgh Expeditions and training. | Thringstone & Whitwick People Zone | £4,514.46 |
