# **Summary of Issue:**

The Capital Programme was presented to the Commissioner for consideration in the Corporate Governance Board on 18<sup>th</sup> January 2023. A decision was not reached therefore a further meeting was scheduled for the 31<sup>st</sup> January 2023 in which the Capital programme was agreed and approved.

The Capital spend for 2023/24 was agreed at £10.9m of which £2.2m was to fund existing projects previously agreed. The following new projects have been agreed as part of the capital programme:
