The Pathfinder Initiative

Summary of Issue:

To provide funding of £29,290.00 for the Pathfinder Initiative. The funding to be weighted toward the first year to support the delivery of 6 Pathfinder events (2 per year) within the Leicestershire PCC area over a three-year period.

Pathfinder is an effective means of reducing KSIs contributing to the development of community safety and road crime reduction in line with the Police and Crime Plan and its requirement for improvement in road safety. Running since 2008 and in multiple locations across the country, evaluation of the results (www.u17ccctrust.org/research/) shows a reduction in collision rates from 1 in 4.5 (DfT Stats) to 1 in 19.

Pathfinder has been running continuously in Gloucestershire, West Mercia and Yorkshire since 2011 (with early experiments in 2008/9) and has provided tuition to around 1500 students over that time.

The statistics gathered by the Pathfinder Initiative provides compelling evidence that the education and experience offered have a significant, measurable impact on the safety of novice drivers. It appears to make them more skilled drivers, demonstrated by the lower accident rate, greater success rate in the DVSA test, and lower likelihood of committing Motoring Offences once qualified.

Graduates of the schemes are very likely to recommend them to others.

Evidence drawn from the work undertaken by the Pathfinder initiative has been submitted to the House of Commons Parliamentary Transport Committee on several occasions for Inquiries into Novice Driver Safety and has influenced recommendations arising. The evidence provided has helped PCCs across the country provide assurance that they are successfully addressing road safety.
