It was agreed to publish a further competition using the Crown Commercial RM6068 Technology Products framework – hardware lot. The evaluation was 100% price and we received six responses. The lowest price was from SCC with a price of £931,688.00.

This has been approved by Paul Dawkins, Assistant Chief Officer (Finance & Resources) and I am requesting that the Police Commissioner signs and seals the contract for this requirement.

# **Background**
