CON786 Disposal of non-Police vehicles extension

Summary of Issue:

An extension to the existing contract is required due to the procurement process for a new contract being aborted due to supplier issues raised. The current arrangement is a framework which is accessed by all East Midlands forces except Lincolnshire.

Background

This extension is to allow for a renewed tender process to be run to ensure that the procurement of the service for the disposal of non-police vehicles is completed compliantly and to also allow additional information to be added to the specification document to account for the clarification questions raised in the original tender that was aborted.

Tender Process

Procurement supports this purchase as it's a continuation of an existing contract and covered by Procurement Contract regulations clause 72 (1)(c) Modifications of contracts during their term.

Modification of contracts during their term

72.—(1) Contracts and framework agreements may be modified without a new procurer procedure in accordance with this Part in any of the following cases:—

(c) where all of the following conditions are fulfilled:-

- (i) the need for modification has been brought about by circumstances which a diligent contracting authority could not have foreseen;
- (ii) the modification does not alter the overall nature of the contract;
- (iii) any increase in price does not exceed 50% of the value of the original contract or framework agreement.

For (c)(i) – the modification is required due to the original tender being aborted, due to issues raised by supplier challenge.

For (c)(ii) – the nature of the contract is not being altered.

For (c)(iii) – the value does not exceed 50%, as for 6 months this would equate to 12.5%.

There is no cost to Leicestershire Police as this is an income generating endeavour. Based on the figures from the original contract then the generation should look as outlined in the table below.
