The majority of the 15 cases for review were chosen at random by the PCC's office. In line with the agreement at the previous meeting a small number were specially selected by individual panel members. Following review the following results were recorded:

6 cases graded as 1 = Appropriate and consistent with policies

7 cases graded as 2 = Appropriate but with observations

2 cases graded as 3 = Inappropriate and inconsistent with policies

0 cases graded as 4 = Panel failed to reach a conclusion

# 6. National Out of Court Disposal Pilot Scheme Update

New project underway. Possibly for 12 months, although no timescales were given. This will involve the PCC Office working with Leicester University and CARA on Hate Crimes using CC on DV Cases – on standard risk – together with 7 other forces who are also included in this project.

Our DV Cases for male victims is lower than other forces and JN enquired if we could use this for standard risks but was advised this is not possible.

Looking to relaunch CARA to Officers and DCI Baker will be meeting with D/Supt Matt Ditcher and invited John/Dave to attend to discuss how to take this forward.
